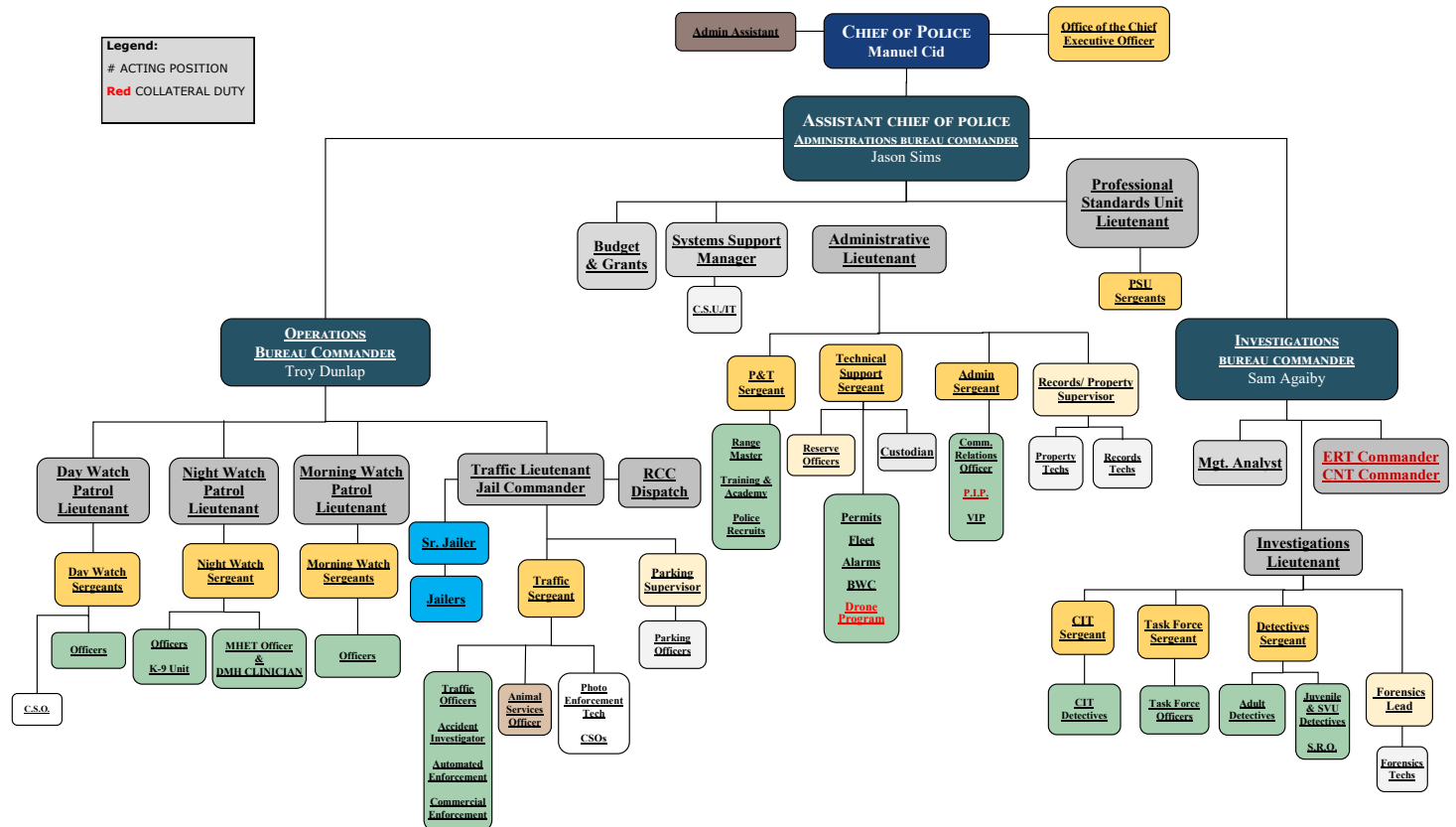

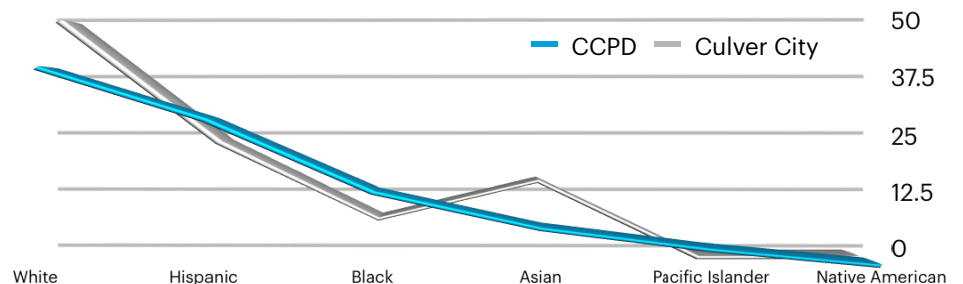

Demographics of Police Department vs. Culver City Population

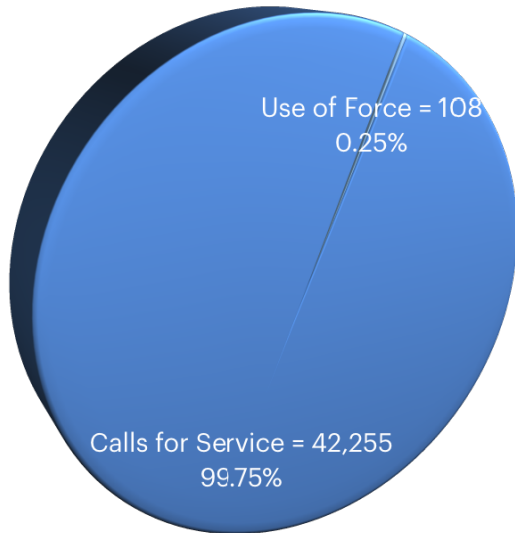

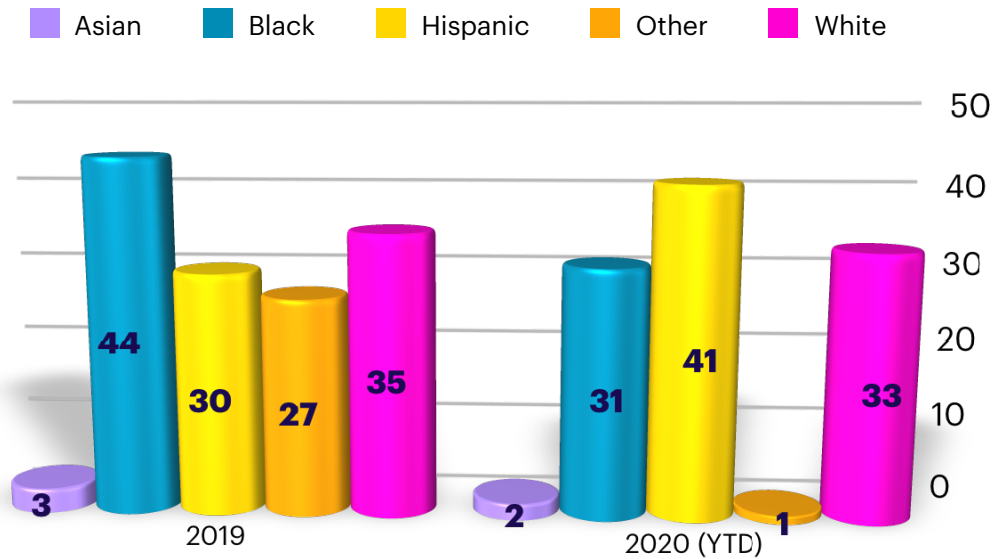

Annual Use of Force per Calls for Service

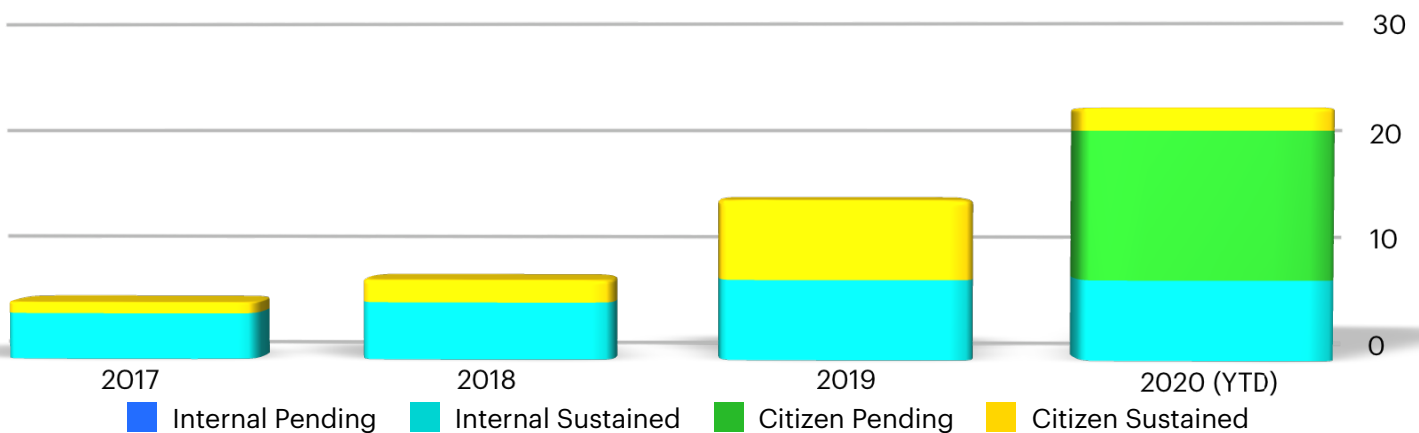


Annual Use of Force by Race

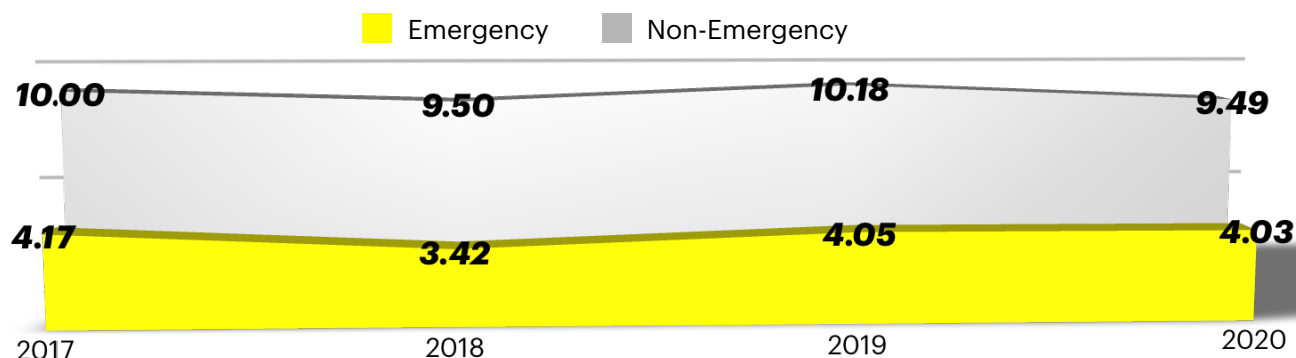

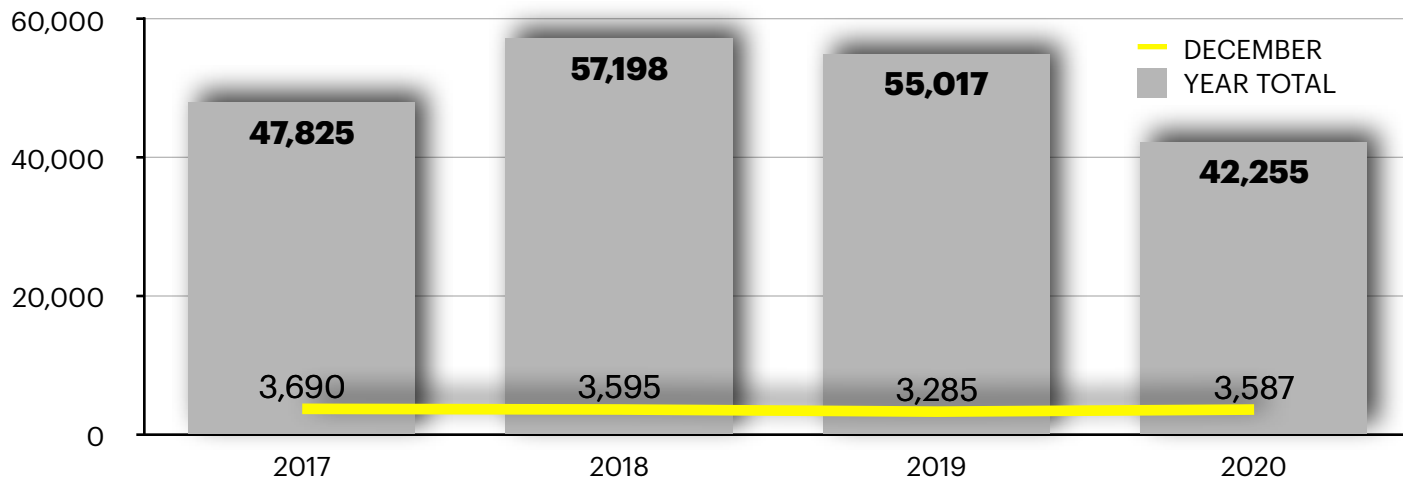
Annual Average Response Time

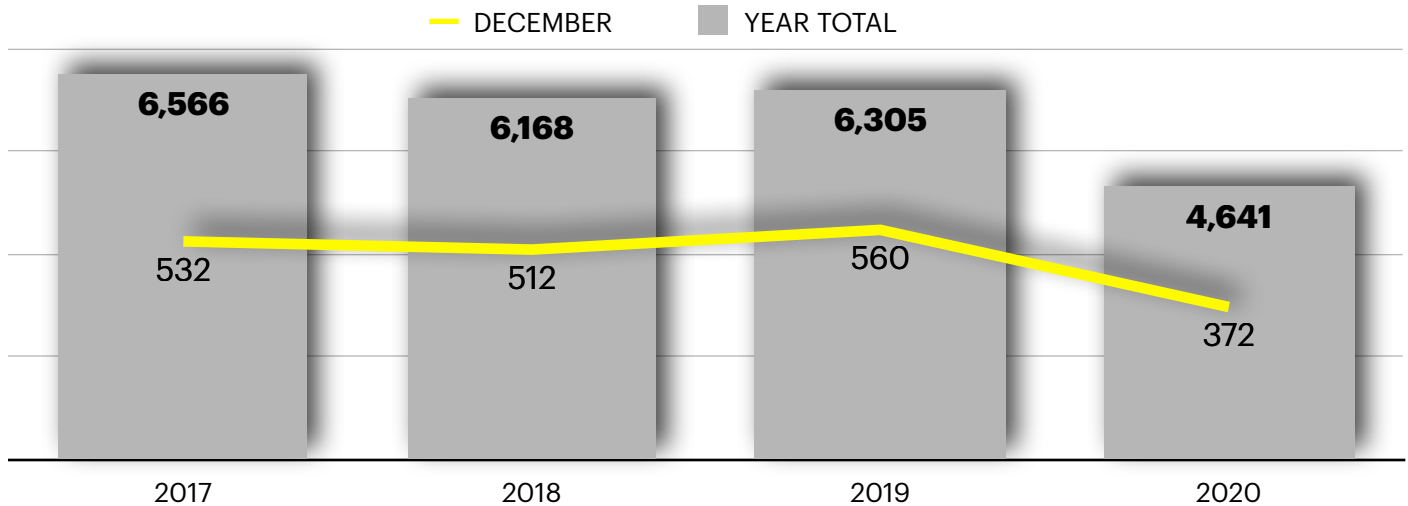

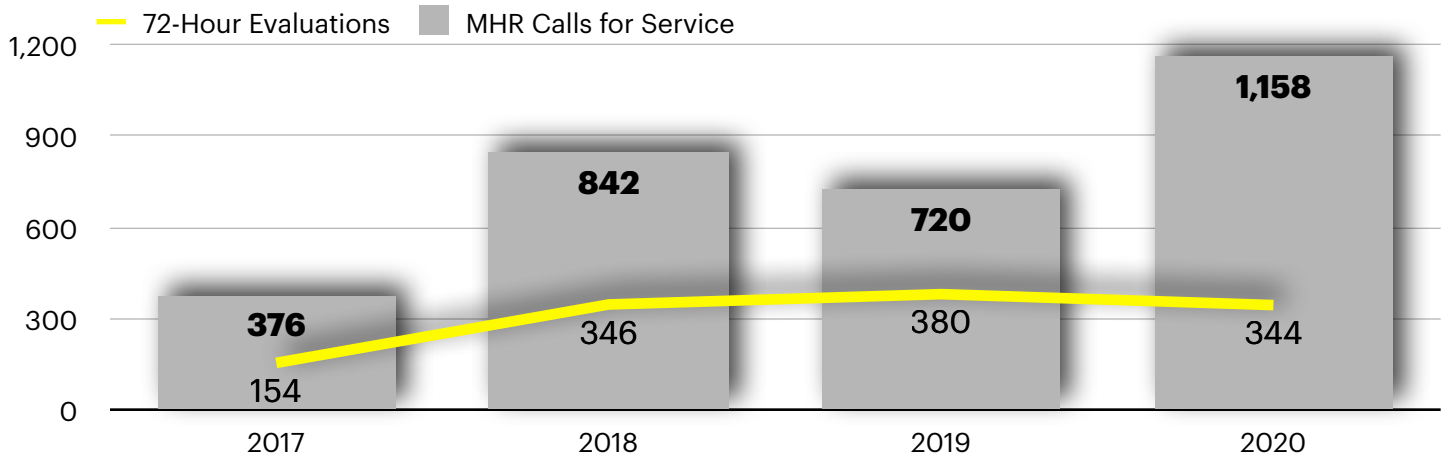

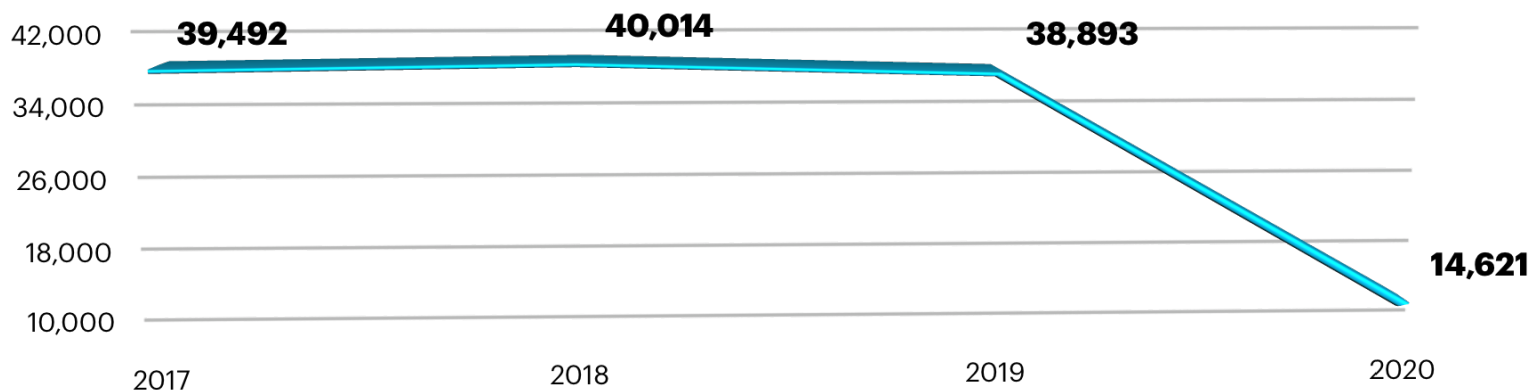

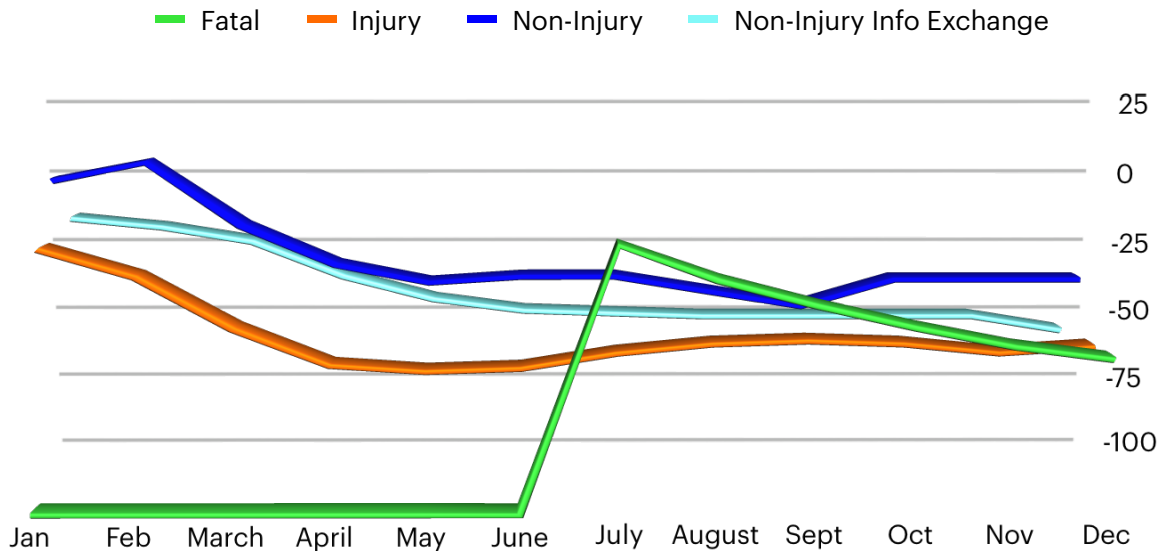

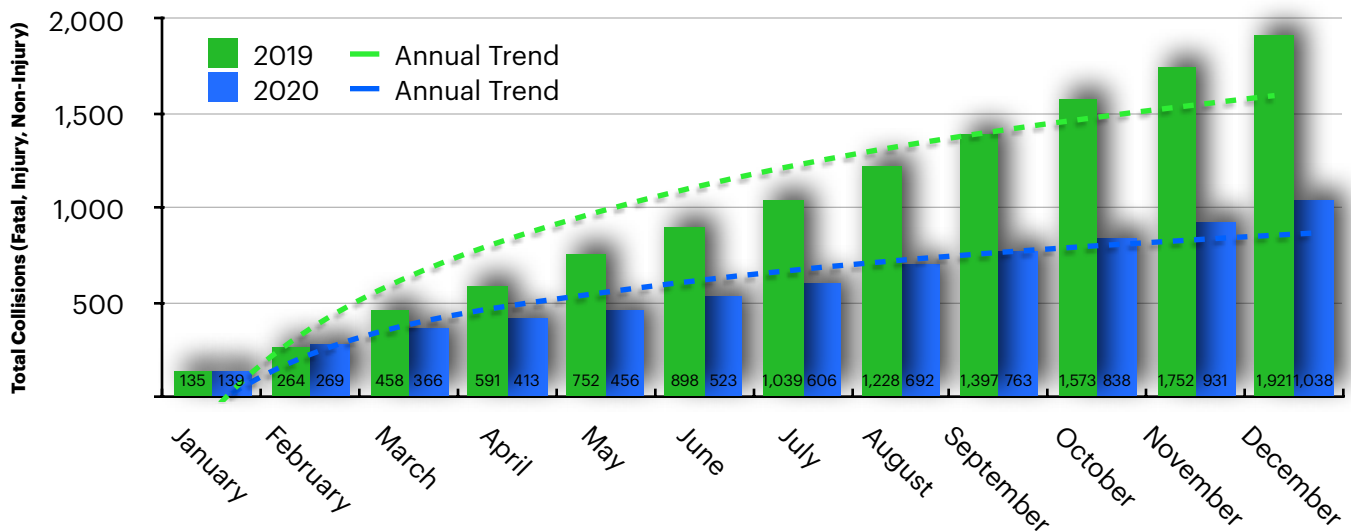

Projected Annualized Change (2019-2020)

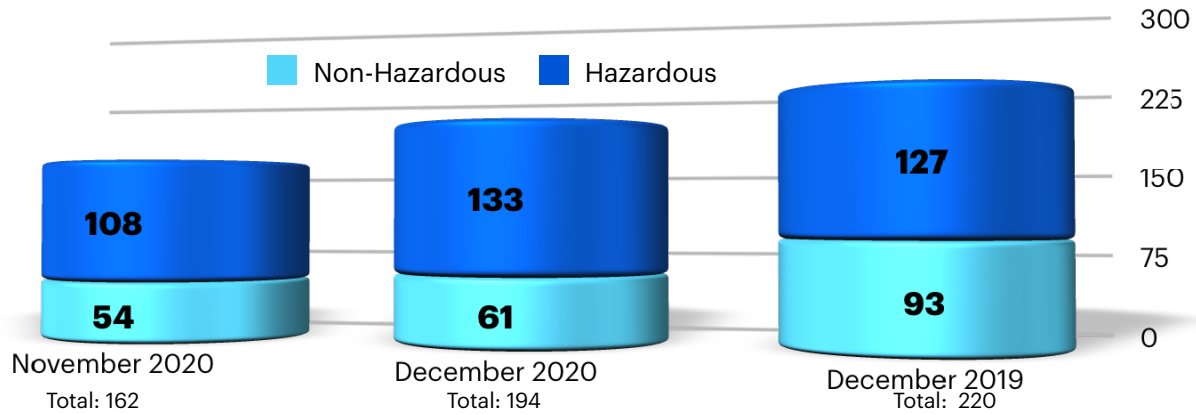


Traffic Collision Trend (2019-2020)



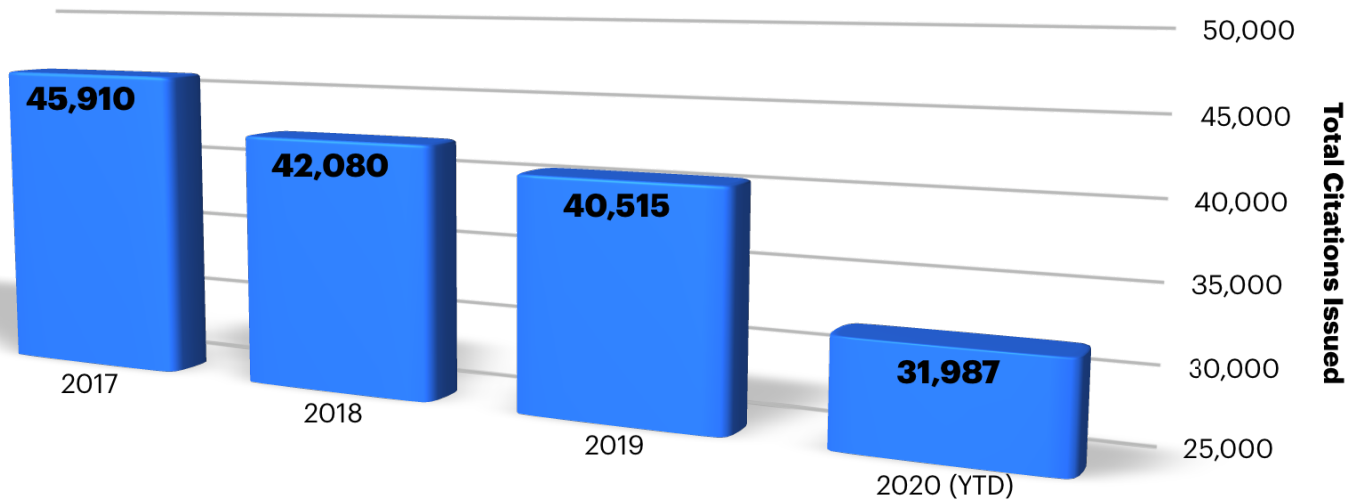

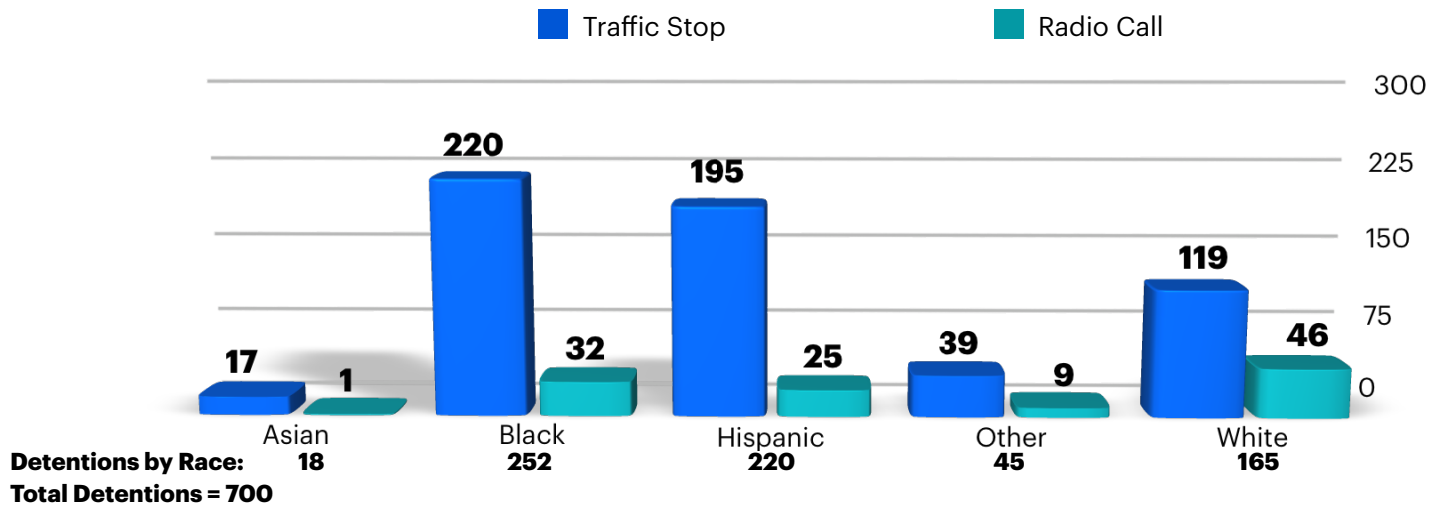
Traffic Stop Detentions & Results (by Race)

The total stops is inclusive of multiple subjects detained during one incident.



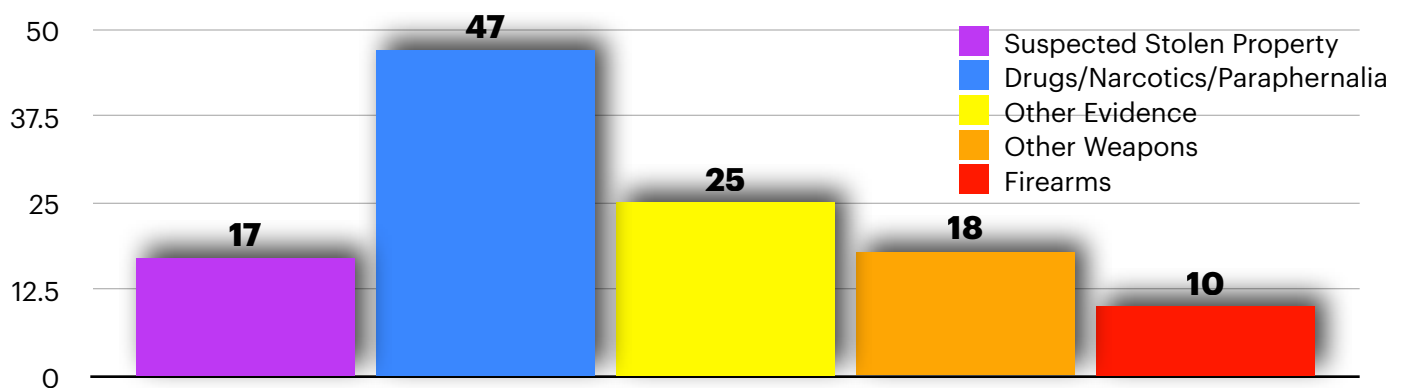

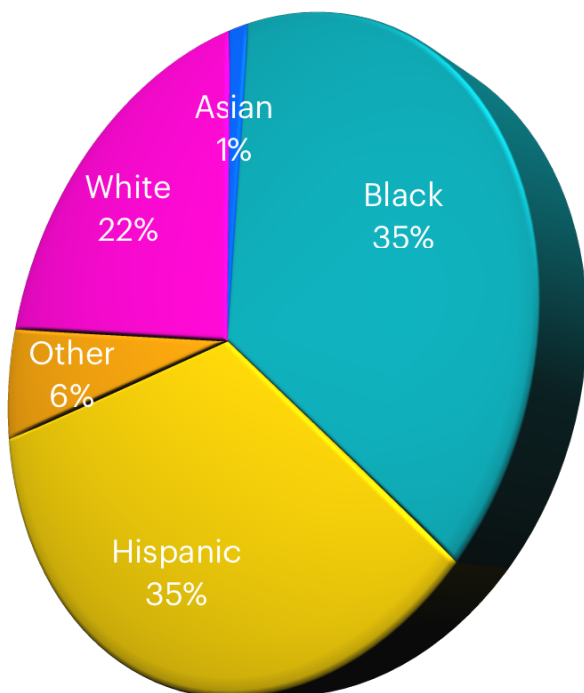

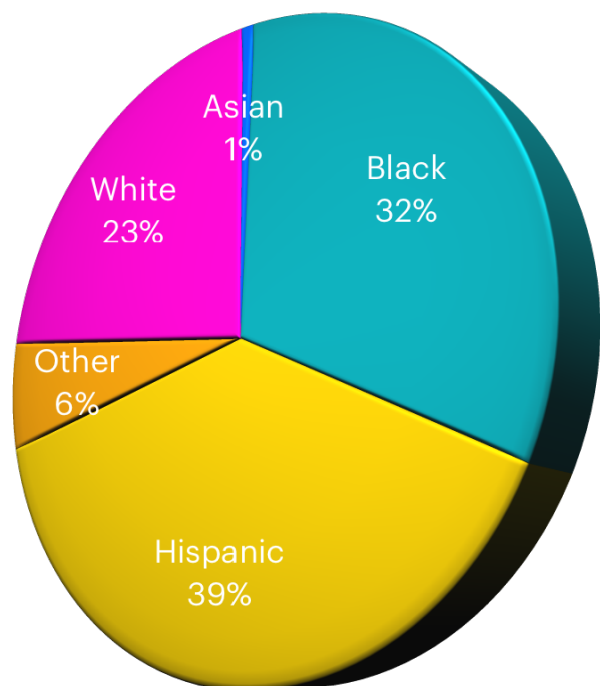

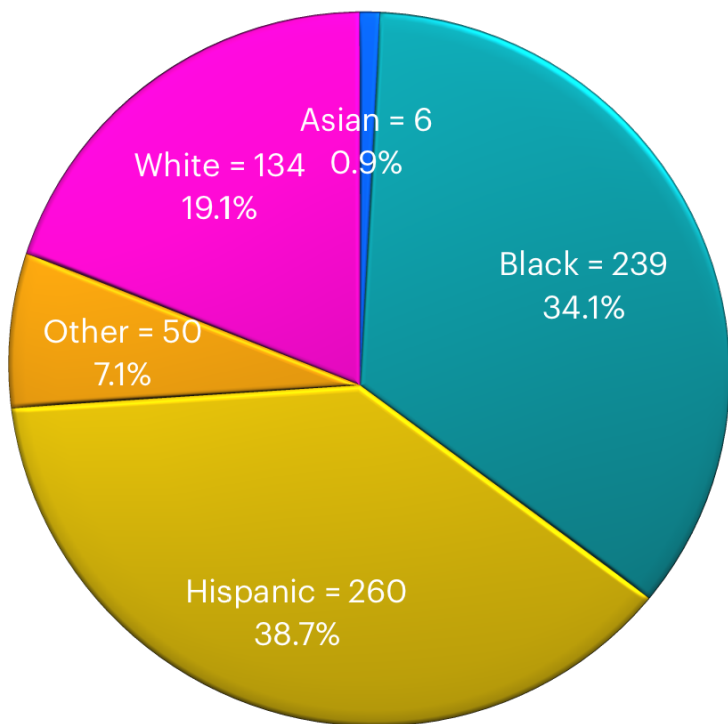

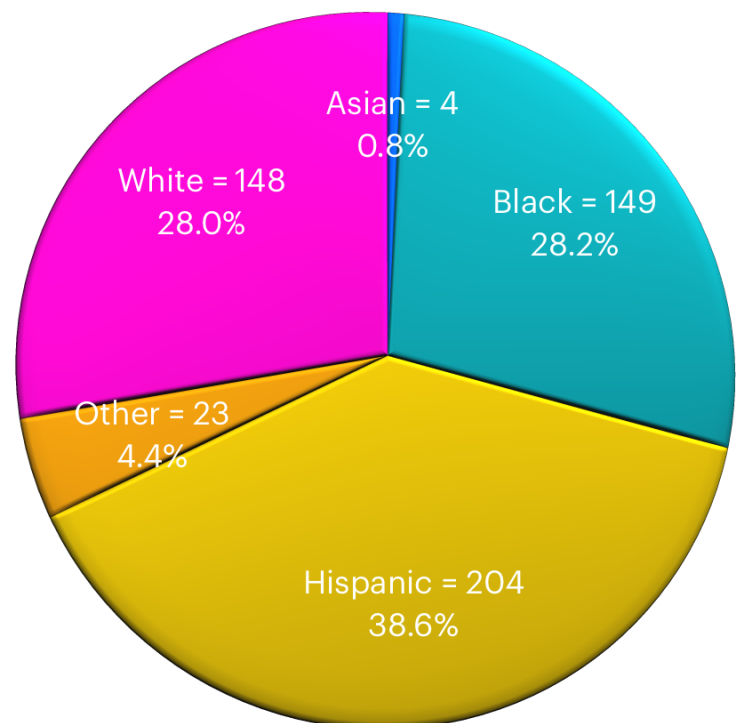

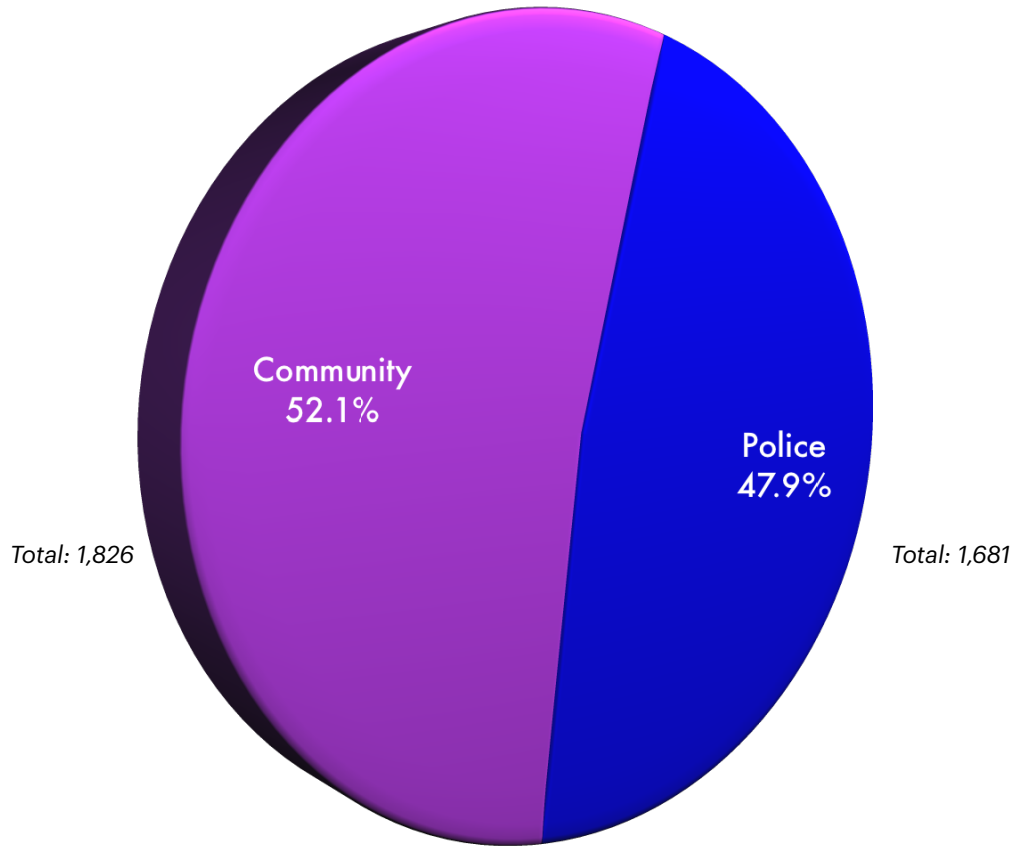
2020 COMMUNITY Generated Arrests by Race

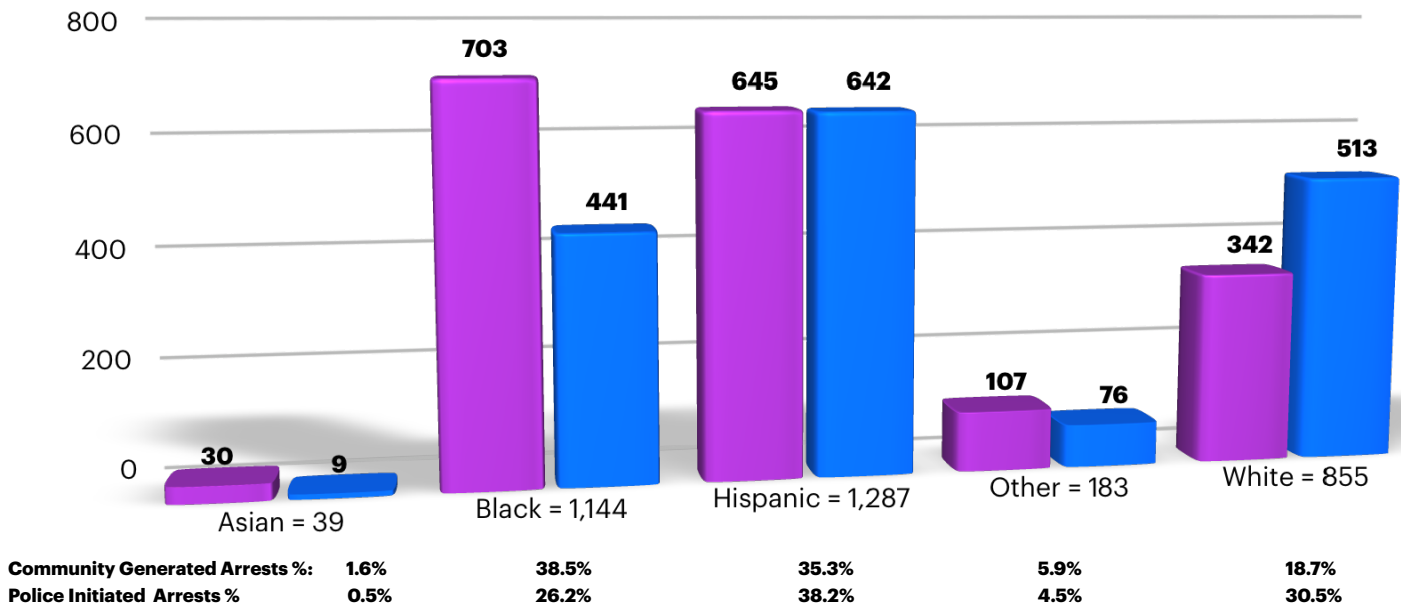
2020 POLICE Initiated Arrests by Race

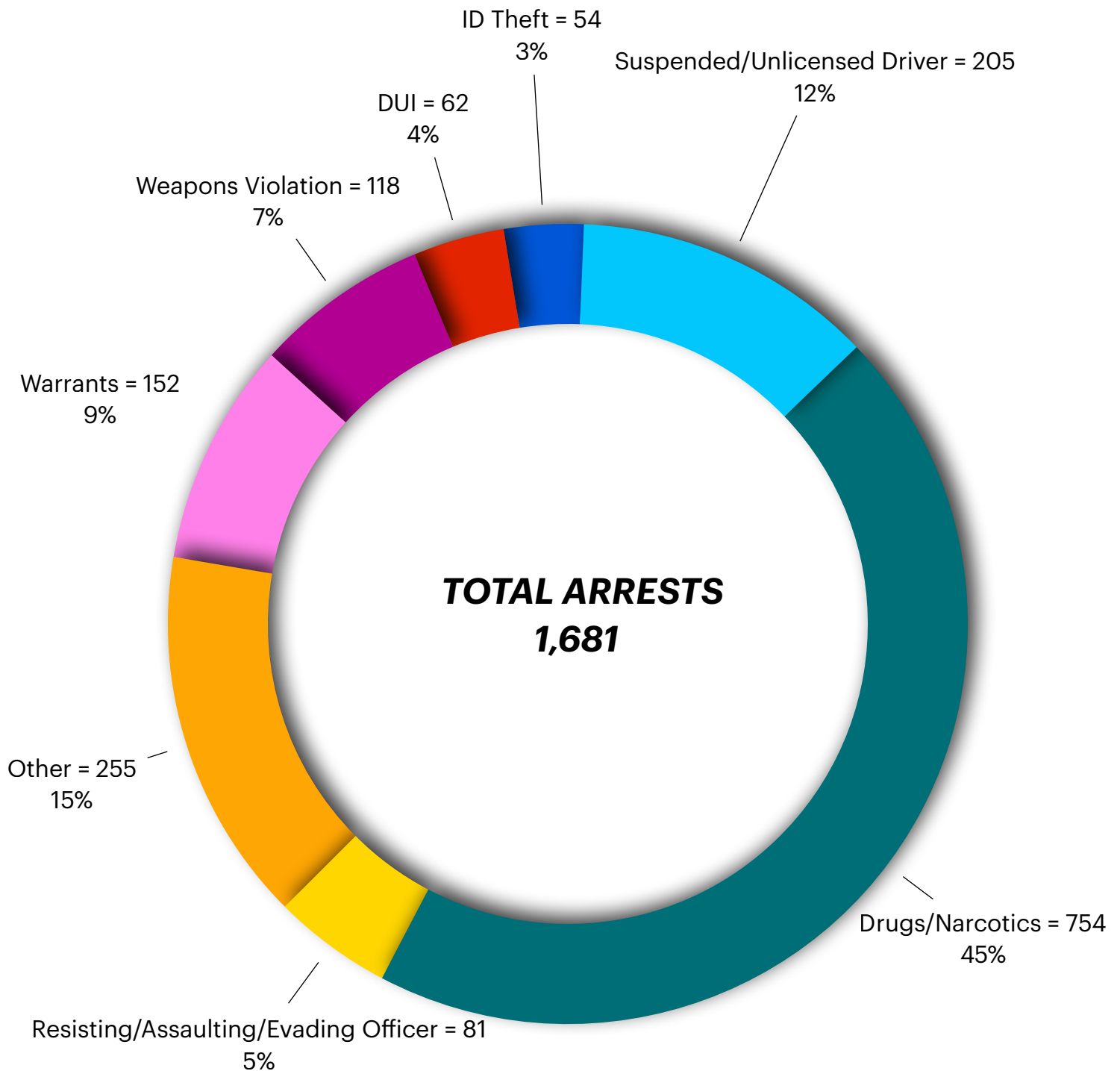
2019-2020 Community Generated vs. Police Initiated Arrests
