Stop Data (RIPA) CollectionAmendments for 2024

Purpose:

This bulletin was created to provide training to CCPD personnel regarding new and amended stop data (RIPA) data collection requirements that become effective on January 1, 2024.

Background:

California Assembly Bill 953 (Racial and Identity Profiling Act of 2015) was introduced by the Calfiornia State Legislature to help develop and encourage a collaborative process between law enforcement agencies and the communities they serve, to end racial and identity profiling, The Department began collecting stop data (RIPA) in Sepember 2020 pursuant to California Assembly Bill 953. As of July 2023, all mandated agencies in California are collecting stop data. A variety of stakeholders, including law enforcement agencies, community members, academics, advocacy groups and the Racial and Identity Profiling Advisory Borad contributed to the newly amended regulations. The stop (RIPA) data fields listed below outline the additions and amendments to the current requirements that take effect on January 1, 2024.

Amended Requirements:

The following fields have been ADDED to RIPA reporting requirements:

REPORTING OFFICER INFORMATION

- Officers Type of Assignment
 - o Added:
 - Special Events,
 - K-12 Public School Resource Officer,
 - Off Duty/Working Private Event,
 - Contracted by Another Law Enforcement Agency,
- Race/Ethnicity of Officer
- Gender of Officer
- Officer working with the non-primary agency in a stop done in conjunction with an agency that is not subject to the reporting requirements of this chapter (Yes/No)

SETTING

- Stop made during the course of performing a welfare or wellness check or an officer's community caretaking function (Yes/No)
- Type of Stop

 - Vehicular Stop,
 - Bicycle Stop,
 - Pedestrian Stop
- Location

 - Geographic Coordinates

OFFICER'S PERCEPTION OF THE PERSON STOPPED

ACTIONS TAKEN
